

Council of Europe Cultural Routes - Call for experts to work with the Enlarged Partial Agreement on Cultural Routes (EPA) in the framework of the Routes4U-project

[Routes4U](#) is a joint programme between the Council of Europe (Enlarged Partial Agreement on Cultural Routes (EPA), Directorate General of Democracy) and the European Union (European Commission, Directorate-General Regional and Urban Policy) for 2017 until 2020. The 30-months project aims to foster the regional development through the Cultural Routes programme of the Council of Europe and focuses on:

- The sustainable and resourceful regional development through the Cultural Routes of the Council of Europe.
- The promotion of cultural and tourism industries in the region.
- The participation of the civil society and local stakeholders.

The project also focuses on the four macro-regions in line with the EU Macro-Regional Strategies of the European Commission:

- Adriatic and Ionian: Albania, Bosnia and Herzegovina, Croatia, Greece, Italy, Montenegro, Serbia and Slovenia.
- Alpine: Austria, France, Germany, Italy, Liechtenstein, Slovenia and Switzerland.
- Baltic: Denmark, Estonia, Finland, Germany, Latvia, Lithuania, Poland and Sweden.
- Danube: Austria, Bosnia and Herzegovina, Bulgaria, Croatia, Czech Republic, Germany, Hungary, Moldova, Montenegro, Ukraine, Serbia, Slovak Republic, Slovenia, Romania.

- **Training on subjects related to the Cultural Routes such as marketing, sustainable tourism, small and medium-size entrepreneurship**

As the subject-matter and regions of the Routes4U-project are very diverse, we are looking for expertise in various areas of culture, economy, tourism, heritage conservation and creative industries, as well as different language competencies. Working languages for drafting reports is English, a very good knowledge of French would be an asset. The list will endeavour to achieve gender and regional balance. Experts from member states of the four macro-regions or with a particular knowledge about the four macro-regions are particularly welcome.

Once included on the list, experts may also be invited to work on other areas related to the cultural routes programme, and/or to attend seminars and conferences, and will receive regular information on activities. **However, please note that inclusion in our database does not guarantee selection for consultancy.**
